REQUEST FOR HEARING TO CONTEST

ADMINISTRATIVE ACTION OF OKLAHOMA TAX COMMISSION

Administrative Law Judge, Oklahoma Tax Commission

I am hereby filing written notice that I contest an administrative action of the

Oklahoma Tax Commission and request a hearing before a duly authorized

Administrative Law Judge of the Commission to appeal said action.

Specifically, I am contesting the denial of my selected personalized license plate

by the Commission's Motor Vehicle Division. On or about July 21, 2016, I

received notice that my selected personalized license plate "COM*MIE" was

refused by the Motor Vehicle Division (MVD). After inquiring as to the reason

for denial, I received an email on July 25, 2016 from the Special Plates Supervisor

of the MVD claiming the selected license plate violates the Commission's Non-

offensive content policy, codified in the Oklahoma Administrative Code as

710:60-3-151(c), though the email did not list any specific way in which the

selected plate violated the policy. The email is attached as Exhibit 1.

Per the instructions in the Supervisor's email, I requested reconsideration. On

August 8, 2015, I received an email sustaining the denial of my requested license

plate. This time, the Supervisor gave more specific reasons for the denial,

claiming that the license plate violated subparts 2 and 6 of the Non-offensive

content policy. The email is attached as Exhibit 2.

I contest this decision based on the following:

- 1. My selected plate does not violate the subparts in question, unless the regulations of the Non-offensive content policy are interpreted and/or employed in an arbitrary and capricious manner.
- 2. The Non-offensive content policy has been created and enforced in violation of the specific statutory mandate found in 47 O.S. 1135.4. This statute requires the Commission to issue my selected plate as a matter of law.
- 3. By enforcing a vague, overbroad, content and viewpoint based discrimination of speech, the Non-offensive content policy violates the Oklahoma Constitution, Article 2, Section 22, which guarantees freedom of speech for all Oklahomans.
- 4. By enforcing a vague, overbroad, content and viewpoint based discrimination of speech, the Non-offensive content policy violates the First Amendment to the United States Constitution, which guarantees freedom of speech for all Americans.

In order to present these arguments in detail, along with the evidence necessary for their factual foundation, I hereby request an administrative hearing, made on the record, with sufficient notice of the date and time to enable the subpoena and attendance of witnesses.

A copy of this request has been forwarded to the Oklahoma Tax Commission, Motor Vehicle Division Special Plate Section, 2501 N. Lincoln Blvd, Oklahoma City, OK 73194, and to the General Counsel's Office of the Oklahoma Tax Commission, at the same address.

Dear Mr. Luttrell,

Here is the relevant promulgated rule of the Oklahoma Tax Commission with respect to personalized license plates:

710:60-3-151(c) Non-offensive content policy. The Commission shall review personalized license plate applications that are not automatically rejected when compared to a database of prohibited or previously issued personalized plates. The Commission shall deny a request if an objective, reasonable person would find that the proposed combination of letters and/or numbers listed on the application falls into at least one of the following categories:

- (1) carries a sexual connotation;
- (2) expresses contempt, ridicule or superiority based on race, gender, politics, ethnic heritage, or religion;
- (3) is vulgar, derogatory, profane or obscene;
- (4) refers to bodily functions, bodily fluids, or intimate body parts;
- (5) refers to alcohol, drugs or drug paraphernalia, illegal activities or gangs; or
- (6) would otherwise be inappropriate for display on a state-issued license plate.
- (d) Other criteria. The criteria in this paragraph are not exhaustive. Dictionaries and compilation of offensive words, terms or letter/number combinations, in any language, gathered from the experience of Oklahoma and other states may also be used as a guide.

The Motor Vehicle Division, in applying this rule to your application, rejected COMMIE on the basis on the non-offensive content policy. If you believe our determination made pursuant to the above guidelines to be erroneous and would like to provide explanatory information or documentation which you believe may impact our determination, please reply to this email with that information.

If this office's denial determination remains unchanged following our review of any submitted additional information, or if you prefer to do so at this time without first providing any additional information to this office, you may, within (30) days of the date of this email, file a written request for a hearing before the Administrative Law Judge of the Oklahoma Tax Commission.
